AIR TRAVEL INFORMATION

You will fly into **Seattle-Tacoma International Airport (SEA)**, which is approximately 30-35 minutes from Smith Cove Cruise Terminal #91.

You need to arrive at the ship by 2:30pm on Friday, July 24th. Failure to check-in by 2:30pm will constitute as a no-show and you will not be permitted to sail. Your reservation will also be cancelled and penalties will apply.

You may reserve your air with Celebrity Cruises® Air/Sea Program (ChoiceAir®) at www.celebritycruises.com/choiceair or by calling (800) 533-7803 (service fees may apply). You will need to give them your reservation number.

If you make your own air arrangements and you do not want the Celebrity cruise ground transfers, please follow the below recommendations:

- **Allow a minimum of three hours** from the time your flight arrives in Seattle to the time you check-in by 2:30pm
- **Allow at least three hours** between when the ship disembarks in Seattle and your plane departs (disembarkation starts at approximately 7:30am)

You can also request to be in one of the first groups to depart the ship by going to the Guest Relations Desk once you board the ship and letting them know that due to a tight airline schedule you need to be included in the first group off the ship.

PASSPORT REQUIREMENTS & IMMIGRATION

Passports are REQUIRED for every passenger, including children and infants. If you do not have a passport, please allow a minimum of 4-6 weeks to receive it after you complete and mail the application. **Your passport cannot expire before January 31, 2021.**

Guests who do not possess the proper documentation may be prevented from boarding their flight or ship, or from entering a country, and may be subject to fines.

Note: No refunds will be given to individuals who fail to bring proper documentation

GROUND TRANSPORTATION OPTIONS

OPTION #1 - Personalized Ground Transportation

If you choose to make your own air travel arrangements, you can still purchase Celebrity Cruises transfers to/from the ship.

In order to reserve ground transportation with Celebrity Cruises®, your flight into the Seattle-Tacoma International Airport must arrive no later than 12:45pm on Friday, July 24, 2020 and your departure flight home on Friday, July 31, 2020 must leave no earlier than 11:45am.

Celebrity Cruise Shuttle Rates:

- \$27 per person (including infants and children), one-way
- \$54 per person (including infants and children), round-trip

If you reserve this ground transportation option, the ground transportation information will be in your cruise documents, which will be emailed to you approx. 2-3 weeks prior to ship embarkation.

Once you have collected your luggage at the airport, you will be met by a Celebrity Cruises® representative outside the Baggage Claim area (or outside of the customs area for international guests) who will assist you with transportation to the ship. When you return from your cruise and have claimed your luggage, a Celebrity Cruises® representative at the pier will direct you to your transportation to the airport.
